The SC32 meetings will be held at the National Institute of Standards and Technology on February 23 - 25, 1998. On all three days, we will meet in Lecture Room C of the NIST Administration Building. One or two additional rooms will be available for computer printers, break-out, etc.

People may want to stay in Downtown DC or in the NIST (Gaithersburg, MD) area. There is public transportation (METRO rail) and a NIST shuttle that can get people between NIST and downtown DC. The actual travel time from Metro center in DC to NIST is about 45 minutes. Connections can take another 30-45 minutes, since the NIST shuttle only goes every half hour. Taxi from the Shady Grove Metro station to NIST only costs about \$7.00.
