1. Introduction

The Editing Meeting for FCD 9579, Remote database Access for SQL, was held in London, England in the week 16th – 20th February 1998.

Delegates representing four national bodies, Canada, Japan, UK and US were represented in person.

The voting for the ballot was 10 NBs in favour, 3 NBs against (Canada, Germany and Japan) and 3 NBs abstaining. The editing meeting received 109 ballot comments in total.

A Canadian ballot comment resulted in the removal of the Distribution Schema from the draft and a request to SC32 to progress this work as a separate subproject.

2. German Ballot Comments

Germany submitted 16 technical ballot comments which were disposed of as indicated in the Disposition of Comments below in a manner which the delegates believe would be acceptable to Germany.

Germany's vote in the ballot was 'no', indicating that despite their approval of the technical content they would not change their vote to 'yes' on the basis that the document was strategically mis-positioned and should be progressed as a Part of ISO/IEC 9075 (SQL) rather than as an independent standard. This is not in line with the agreed programme of work of SC21 and SC32. Moreover, progressing the document in this way is not practical since (a) SQL is an abstract language standard, RDA is a concrete implementation, (b) the technical expertise to develop and promote RDA is outside the DBL group, (c) SQL is a very large standard – the line has to be drawn somewhere: secondary areas such as RDA, SQL/MM and IRDS can, and should, be progressed independently.

3. Outcome of Meeting and Recommendations

All comments received were considered by the meeting and resolved to the satisfaction of the NBs represented at the meeting. All national bodies represented that had voted negatively converted their vote at the end of the meeting.

In order to resolve a Canadian ballot comment the meeting agreed to progress the Distribution Schema element of the work separately from the rest of the document and has requested that the project be split in order to accommodate this.

The meeting voted unanimously to progress the document and to request that it be circulated for FDIS ballot.
