Resolution WG 1/1: SC32 Business plan

SC32/WG1 requests SC32 to revise the draft Business Plan by removing the project 30.02.00.00.00 from the Projects List. The rationale for doing this is, that the project has been subdivided into three parts (30.02.01.00.00, 30.02.02.00.00 and 30.02.03.00.00) which are already listed in the Business Plan. Therefore there is no need to show the earlier project number on the list.

Furthermore, SC32/WG1 requests SC32 to add Mr. Paul Levine as project editor for projects 30.02.02.00.00 and 30.02.03.00.00 and Mr. Hannu Pelkonen as project editor for project 30.04.00.00.00.

Resolution WG 1/2: CD 15944-1 Editing

SC32/WG1 instructs the editor of 15944-1 to revise the draft document resulting from the SC32/WG1 Helsinki meeting. Additional comments shall be sent to the editor by the 4th of October. The project editor is requested to submit the draft CD to the SC32/WG1 Secretariat no later than the 8th of October 1999.
