Request for contributions on Formal Description Techniques

In its efforts to develop the BOV related standards of Open-edi, the workgroup formally known as SC32/WG1, identified the need for Formal Description Techniques (FDTs) for Open-edi Scenarios. The scenario concept is defined in IS 14662 (Open-edi Reference Model) and the initial set of requirements on suitable FDTs are described in document SC32/WG1 N135 (CD 15944-1). In order to be able to identify proper candidate techniques, SC32/WG1 now asks for input about specific Formal Description Techniques that might satisfy these requirements. Such candidate techniques should be explained in relation to concepts and terminology found in IS 14662 and SC32/WG1 N135 (CD 15944-1).
