1. Overview:

The ballot resolution on the PAS submission of both ISO/IEC19502 (MOF) and 19503(XMI) had completed successfully by the end of March, 2005.

Attached are the Final DIS documents of both MOF and XMI and the list of comments that were reflected on the final documents.

2. History:

- (1)The PAS submission on both MOF and XMI were made by OMG on the March of 2004. ISO/IEC JTC1 SC32 was assigned to hold the comments resolution meeting and to edit FIDS documents.
- (2) The Ballots on both MOF(ISO/IEC DIS19502) and XMI ((ISO/IEC DIS19503) were initiated on 22nd June of 2004 and closed on 22nd December, 2004.
- (3) 2 out of 16 P-members voted "Disapproval with comments" on both MOF and XMI. Two National bodies were JP national body and GB (UK) national body.
- (4)The ballot comments resolution meeting was held on 1st February, 2005 at Burlingame, California, US as a part of OMG TC meeting. The attendees were listed on the Attachment-3.
- (5) GB was not able to send a representative to the meeting, but the result of the resolution was reviewed by GB and agreed
- (6) The PAS submitter, OMG revised the documents of both MOF and XMI as the final DIS documents
- (7) The members of the comments resolution group confirmed the revisions

4. Major comments

The list of comments on both MOF and XMI balloting are shown on Attached -2 and 3.. All of the comments were resolved. However, GB wishes to remain the comments on the copyright statement in ANNEX-C on both MOF and XMI. GB suggests that the more precise investigation on the expression of the copyright or the Intellectual property right on the standards submitted by PAS submission bodies should be needed to be done by ISO CS.

MOF/XMI PAS Ballot Resolution Process

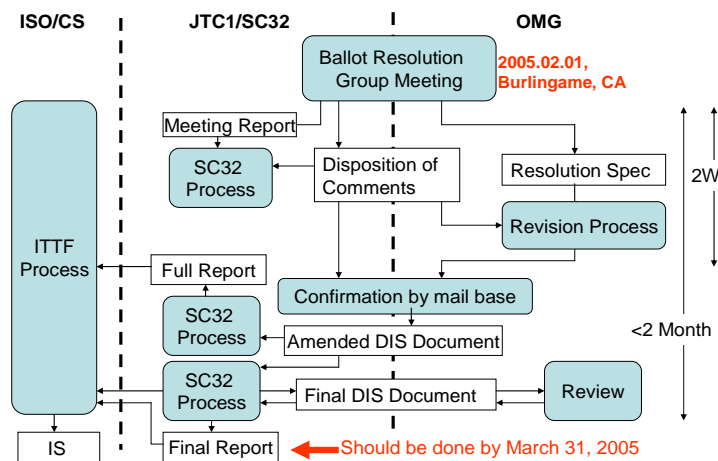


Fig.,-1 process for comment resolution
